Notice of Election by Electoral Officer

Date: 22 June 2026

Notice is hereby issued for the conduct of elections to constitute the Executive Committee of the Indian Rope Skipping Federation (IRSF) for the upcoming term (2026–2030). The election proceedings will be conducted under my direct supervision, control, and statutory authority as the designated Independent Electoral Officer, in strict accordance with the provisions of the National Sports Governance Act (NSGA), 2025, the National Sports Governance Rules, 2026, and the Constitution of IRSF.

The Composition of the 15 Executive Committee Posts In accordance with Section 4 of the National Sports Governance Act (NSGA), 2025, the National Sports Governance Rules, 2026, the Constitution of IRSF and the statutory guidelines mandating strict gender balance and direct athlete integration, the Executive Committee shall comprise a maximum of 15 members structured specifically as follows:

1. President: 1 Post (General)
2. Senior Vice President: 1 Post (Mandatory Female)
3. Vice President: 2 Posts (General)
4. General Secretary: 1 Post (General)
5. Joint Secretary: 4 Posts (1 Mandatory Female and 3 General)
6. Treasurer: 1 Post (General)
7. Executive Committee Member: 1 Post (General)
8. Sportspersons of Outstanding Merit (SOM): 2 Posts (1 Male and 1 Female)
9. Athletes Committee Representatives: 2 Posts (1 Male and 1 Female – Inducted directly via election from the internal Athletes Committee)

TOTAL STRENGTH: 15 Members (Ensuring the statutory mandate of at least 4 female members and 2 SOMs)

Submission of State/UT Representatives (Electoral Roll) : Each duly recognized and affiliated State/UT Member Association is required to submit the names of two (02) authorized delegates who shall represent their respective association and possess voting rights for the election of the Office Bearers and members of the Executive Committee of IRSF. The submission window for the nominations to the Electoral Roll opens at 9:30 AM on 22 June 2026 and closes strictly at 5:00 PM on 23 June 2026. Submissions received outside this designated timeframe will not be considered for the compilation of the Electoral Roll.

Election Framework & Timeline: The detailed, binding schedule specifying timelines for the submission of nominations, scrutiny of candidatures, withdrawals, and polling will be independently notified by my office. All official communications, electoral lists, and prescribed forms will be hosted transparently on the official IRSF website.

Candidate Eligibility Criteria Statutory Alignment: All contesting candidates must strictly fulfil the eligibility and clear conduct conditions laid down under the National Sports Governance Act (NSGA), 2025, the National Sports Governance Rules, 2026, and the Constitution of IRSF.

- Age Threshold: All nominating candidates for the Executive Committee positions must be between 25 and 70 years of age on the date of filing nominations.
- The age criteria for Athlete Committee representatives shall be governed by the specific provisions within the IRSF constitution.
- Tenure and Cooling-Off Compliance: Candidates contesting for the core positions of President, General Secretary, and Treasurer remain subject to the term caps (maximum of three consecutive terms in combination or same role) and mandatory cooling-off periods explicitly mandated under the NSGA 2025.
- Electoral Validity: Only validated delegates featured on the finalized Electoral Roll are legally eligible to propose, second, or contest an election for any of the Executive Committee positions.
