21 June 2026		Appointment of Electoral Officer pursuant to the resolution of the General Body and the formal resolution/authorisation of the incumbent Executive Council. The appointment letter shall be issued by the President.
22 June 2026	DAY 1	NOTIFICATION AND CALL FOR EXECUTIVE COMMITTEE ELECTION (13 POSTS) by Electoral Officer at 9:00 AM on Day 1 , call for election to 13 contested positions forming part of the 15-member Executive Council, comprising 11 elected office-bearer/member positions and two SOM positions. The remaining two positions shall be occupied by one male and one female representative already elected by the Athletes Committee. The timeline of elections will be notified on the website after provision from the Electoral Officer at 9:15 AM. Circulation of Special General Meeting/EC Election notice with member States/UT at 9:30 AM under the direct authority of the Electoral Officer.
22 June - 23 June 2026	DAY 1-2	EACH DULY RECOGNIZED AND AFFILIATED STATE/UT MEMBER ASSOCIATION SHALL INTIMATE THE NAMES OF 2 REPRESENTATIVES TO THE IRSF WHO SHALL REPRESENT THE STATE/UT MEMBER ASSOCIATION AND VOTE IN THE ELECTIONS OF THE EXECUTIVE COMMITTEE OF IRSF on 22 June (From 9:30 AM) to 23 June (Till 5 PM)
23 June 2026	DAY 2	PREPARATION AND RELEASE OF DRAFT ELECTORAL ROLL : IRSF shall collect the names, authorisation letters and requisite details of the representatives nominated by the eligible Full State/UT Member Associations, along with the details of the eligible Sportspersons of Outstanding Merit forming part of the General Body, in Form 1. IRSF shall compile the complete proposed list, together with supporting records, and furnish the same to the Electoral Officer within the prescribed timeline. The Electoral Officer shall thereafter, in consultation with the incumbent Executive Committee, prepare and release the draft electoral roll in Form 1 by 9:00 PM.
24 June- 30 June 2026	DAY 3 - DAY 9	RECEIPT AND DISPOSAL OF OBJECTIONS TO THE DRAFT ELECTORAL ROLL: Objections may be submitted to the Electoral Officer from 9:00 AM on Day 3 until 6:00 PM on Day 9. The Electoral Officer shall examine and dispose of the objections before publication of the Final Electoral Roll.
1 July 2026	DAY 10	RELEASE OF FINAL ELECTORAL ROLL: The Electoral Officer shall release the Final Electoral Roll in Form 1 and publish the same on the official IRSF website by 6:00 PM on Day 10, after disposal of all objections received against the Draft Electoral Roll.
2 July- 4 July 2026	DAY 11-13	FILING OF NOMINATIONS: Each candidate shall personally file the nomination in Form 2 before the Electoral Officer from 9:00 AM on Day 11 until 3:00 PM on Day 13. This requirement shall also apply to candidates contesting the SOM positions. .
4 July 2026	DAY 13	ANNOUNCEMENT OF DRAFT LIST OF NOMINATIONS RECEIVED: After 3:00 PM on Day 13, the Electoral Officer shall prepare a list of all nomination papers received by him in Form 3 and scrutinize each paper received by him and determine its validity or otherwise and then publish the same in his office at 7:00 PM, and also at the IRSF website.
5 July- 6 July 2026	DAY 14-15	OBJECTIONS TO NOMINATIONS RECEIVED: Objections to any nomination included in Form 3 may be submitted to the Electoral Officer from 9:00 AM on Day 14 until 5:00 PM on Day 15, together with the grounds and supporting documents.
6 July 2026	DAY 15	SCRUTINY & DISPOSAL OF OBJECTIONS to draft list of nominated candidates by Electoral Officer on Day 15
7 July 2026	DAY 16	FINAL LIST OF VALIDLY NOMINATED CANDIDATES IN FORM 4: Release of final list of validly nominated candidates on Day 16, after 6:00 PM by Electoral Officer and on IRSF website.
8 July 2026	DAY 17	WITHDRAWAL OF NOMINATIONS: A candidate may withdraw his or her candidature by personally submitting Form 5 to the Electoral Officer by 5:00 PM on Day 17. Once accepted, the withdrawal shall be final.

9 July 2026	DAY 18	FINAL LIST OF CONTESTING CANDIDATES: At 11:00 AM on Day 18, the Electoral Officer shall prepare the Final List of Contesting Candidates in Form 6 and display the same at the Electoral Officer's office and on the official IRSF website.
11 July 2026	DAY 20	POLLING, COUNTING AND DECLARATION OF RESULTS: Polling shall commence at 12:30 PM on Day 20 by secret ballot. Counting shall be undertaken immediately after the close of polling, and the results shall be declared by the Electoral Officer and published on the official IRSF website.
